Qualifications with relevant dates	Self-explanatory
BDA Membership – including the date membership commenced	For a life membership the nominee should have been a member of the association for 25 years continuously or a member for 10 years continuously who has ceased to practice dentistry and holds no paid dental appointment.
Honour or Award for which they are being nominated (please refer to the attached guidance for categories)	Life Membership - If the nominator is unsure which award the member should be nominated for it can be left to the discretion of the Honours and Awards Committee.

#### Career Information

The nominee does not have to be aware of the nomination but it is difficult to fill in this form, especially the career information, without sight of the nominee's cv. Detailed information and dates can be difficult to include without asking the nominee and in some cases even this does not help. If you are not sure of detailed dates do not include them.
